PROCEDURE

1. Heat A to 88°C under stirring.
2. Heat B to 80°C under stirring.
3. Mix C at room temperature.
4. Add A to B and keep stirring.
5. Add C to A+B and homogenize for 30 sec.
6. Pour directly into specific packaging and let cool down to room temperature.
